- i. Copy of PAN Card, VAT Registration and/or Sales Tax Registration Certificate, duly self attested shall be provided.
- ii. Tender with counter conditions will not be entertained.
- iii. It may be acceptable to the bidder that once the order is accepted, the bidder is bound to execute it within the period specified and no request for increase in rate subsequently nor any excuse for not executing the order on account of any unforeseen circumstances will be entertained. NO advance payment shall be made against our order, if any, placed with you.
- iv. If after the item is delivered, it is discovered that the material supplied, is not exactly according to our specification/quality stipulated, such supply will be rejected at the suppliers' cost.
- v. Printed material must be properly delivered locally at the address given in the Tender document.

1. Bid Prices:

- i. The prices shall be quoted in Indian Rupees only.
- ii. The prices shall be quoted for destination and no additional cost for delivery will be entertained and this shall be inclusive of all taxes, duties etc.
- iii. All taxes, duties etc. leviable should be clearly indicated
- iv The prices quoted shall remain firm and fixed for the duration of the delivery and shall not be subject to adjustment on any account.

2. Correction of errors

In the process of evaluation of Financial Bids, following procedure will be adopted for correction of errors:

- 1. Where there is a discrepancy between the rates in figures and in words, the rate given in words will govern.
- 2. Where there is a discrepancy between the unit rate and the total cost, the total cost arrived at by multiplying the unit rate to the quantity, will govern.

The amount stated in the Bid will be corrected in accordance with the above procedure for removal of errors and shall be considered binding upon the Bidder. If the Bidder does not accept the corrected amount, the Bid will be rejected, and the Earnest Money shall be forfeited.

3. Bid Evaluation and Award Criteria

The price bids of those bidders, who fulfil the eligibility criteria, will be evaluated as under:

i) The Purchaser shall award the purchase order to the bidder whose offer has been determined to be the lowest evaluated bid for bid as a whole and is substantially responsive to the bidding documents, provided further that the
