

Shri Anthony,

Kindly refer to telephonic discussion I had with you today.

Since we do not have any other person suitable for this post, we have  
for his extension of deputation period vide our letter No.529/RC/08 dated 23.10.2008. We have  
No.35018/15/2001/MF.CGA(A)/Gr.B/285 dated 28.05.2009.

On our request to place some competent person on deputation, it was informed vide your  
letter No. 35018/15/MF.CGA(A)/Gr.B/1035 dated NIL that since Pay Scale of the post of Pay &  
Accounts Officer of Jharkhand Bhawan is in Rs.6500-10500/- which is equivalent to the pay  
scale of a Jr. Accounts Officer of your organization, no candidate is available in this scale for  
Accounts Officer.

It was further suggested that if the pay scale of the post of Accounts Officer in Jharkhand  
Bhawan is upgraded in the scale of Rs.8000-13500/-/10000-15200/- (unrevised) to bring it at par  
with the scale of Sr. Accounts Officer or Accounts Officer of your organisation, it would be  
easier to identify suitable candidates for this position. Accordingly, on our request, the State  
Government has upgraded the Pay Scale to Pay Band-III 15600-39100/- Grade Pay 6600/-  
(Revised) 10000-15200 (unrevised).

In the above circumstances it is requested that an eligible, willing and suitable officer  
may please be posted in Jharkhand Bhawan as Accounts Officer to ensure financial discipline in  
accounting system in our office.
