(a) Holding analogous post on regular basis in the parent cadre or department; or

(b) With five years' service in the grade rendered after appointment thereto on a regular basis in posts in the Pay Band-3 (Rs.15600-39100) or Pay Band-2 (Rs.9300-34800) with Grade Pay of Rs.5400/- or equivalent in the parent cadre or department; or

(c) With six years' service in the grade rendered after appointment thereto on a regular basis in posts in the Pay Band-2 (Rs.9300-34800) with Grade Pay of

Rs.4800/- or equivalent in the parent cadre or department.

(II) Regulation of pay and other terms of deputation:

(III) Age-limit:

The maximum age limit for appointment by deputation shall not exceed **56** (fifty six) years as on the closing date of receipt of applications.

(IV) Nature of duties:

The Dy. Director (Cost & Finance) will be responsible for preparation of Budgets and all expenditure statement connected with Budget work.
